Not only had he influenced many enlightened thinkers like John Locke, David Hume and Edmund Burke. Still his writings are most influential in European culture and primary materials for writing and knowing Roman history. Cicero was greatly influenced by Philo of Larissa, the last head of the Academy. In the field of

Ethics, his favor is based on the Stoic school of thought rather than Epicurean tradition.<sup>3</sup> As we know that he was a political man so his philosophy is totally for the purpose of politics. He thought that only philosophy can save and improve the political system and since he was greatly influenced by Greek philosophy so he translated it into Romans, and sometimes invent new words in Latin where none seemed suitable for Greek concepts so that the Romans audience can understand easily and can use the Greek philosophy effectively.<sup>4</sup>

And the criterion of good men is knowledge, wisdom. No one can be good unless he is wise.<sup>6</sup> To know good things and to understand the friend are the two chief elements to sustain friendship.

It is the good will and feeling of affection which strengthen the relationship of friendship. For Cicero the utility based friendship i.e. the friendship which is cultivated not for the affectionate feeling but for some materials utilities and mutual utility. Those who believe that friendship is like this are doing nothing less than 'tearing the very sun out of the heavens.' The friendship of rich and poor, weaker and stronger people etc. are some unequal relations of friendship which are purely based on mutual utility. Cicero thinks that true friendship is a noble thing, what we receive in true friendship is not only material profit but the affection and it is the delightful gift of mankind given by the god.<sup>9</sup>

#### **Duties towards Friends:**

To maintain the friendship we have to follow some rules and regulations, we should not demand from our friends those things which are not right. Never expect those things which you also cannot give to others. If our friends are facing problems and falling into depression then it is our duty to stimulate him. We ought to do something so that he can regain his self confidence. Not only that, the good friend's duty is to help in knowing the capabilities of the friend and drive his friend towards the hopefulness and optimistic opinions.

Every person's nature and character is different and we have to accept this. The only thing we have to look at is whether he is following any ideal or not. All ideals are good in their own way. We have to respect the feelings, emotions and ideals of every person. Moreover if we remove emotions from man then he or she will become like a stone or trunk of the tree.
